Transfer Center

The Transfer Center has many resources to support student transfer. A Transfer Day is held on campus every fall and representatives of four-year colleges visit the center year-round. The Transfer Center is located in room 1335 or can be reached at 707-256-7333.

Transfer Success

Napa Valley College is the bridge for many students to a four-year college or university. Academic standards are high and follow-up studies show that our students excel in four-year programs. Our top transfer schools are in close proximity— Sonoma State, Sacramento State, San Francisco State, UC Davis, and UC Berkeley. Students also transfer to many independent and out-of-state institutions. The college has Transfer Admission Guarantees with UC Davis, UC Santa Cruz, UC Santa Barbara, UC Riverside, UC San Diego, UC Irvine, UC Merced, and St. Mary's College.

Application Deadlines

For Fall semester admission, all materials must be submitted by **May 1**.

For Spring semester admission, all materials must be submitted by **October 1**.

Admission Steps & Required Documents

Choose Your Program

F-1 Students are permitted to take any Associate of Arts (AA), Associate of Science (AS) or Associate Degree for Transfer (AD-T).

Complete Online Application Form

Submit your personal and academic information online to begin the application process. Be sure to select your program of study before submitting.

Copy of Passport

A clear, valid copy of the photo identification page from your passport issued by your home country is required.

Bank Statement

A bank statement no older than 6 months is required to verify financial resources for the applicant. Documentation must show that applicants meet the required financial minimum for a full academic year (*\$32,866). If your account is outside the U.S., the bank must stamp or sign the statement for verification. Students requesting an F-2 Dependent I-20s must also provide proof of an additional \$5,000 in financial support per dependent.

**Please note: The financial minimum requirements for F-1 students are set on an annual basis and are subject to change without prior notice.*

Financial Certification Form

(Only Required for Students with a Sponsor or Family Member Covering Expenses)

The Financial Certification Form is required for all applicants who will not be self-funding their education. If a family member, sponsor, or other third party will be paying for your tuition and living expenses, this form confirms their commitment to financially support you while studying at Napa Valley College.

F-2 Dependent Requirements

(Only Required if Requesting Dependent (F-2) I-20s)

Students requesting dependent (F-2) I-20s must submit a clear, valid copy of the photo identification page from each dependent's passport issued by their home country, and the financial support documentation must show an additional \$5,000 USD per dependent.

Transfer Students

Students transferring from another U.S. college or university must submit copies of all previously issued I-20s from any institutions they have attended. A completed Transfer Form, signed by the current Designated School Official (DSO), is also required if applicable. In addition, students must confirm their eligibility for a SEVIS record transfer and ensure that a SEVIS transfer release date has been scheduled. A copy of the student's most recent I-94, available at i94.cbp.dhs.gov, must also be provided as part of the transfer documentation.

Admission Steps & Required Documents (cont.)

English proficiency test scores and official transcript evaluations may be submitted electronically through the respective testing or credential evaluation service portals:

English Proficiency Test Score

- Official English Proficiency Exam scores may be submitted directly to Napa Valley College. We accept scores from the following tests, with the minimum required scores listed below:

English Proficiency Exams	Minimum required
TOFEL	Computer-based (133) Internet-based, iBT (45) Paper-based (450)
Duolingo English Test	Score: 75
IELTS	Band: 5.0
ITEP	Undergraduate 3.0 level
Oxford ELLT	Score: 4

Applicants may waive the English Proficiency Exam requirement if they meet one of the following:

- **Primarily English-Speaking Country Waiver** – Students from any of these primarily English-speaking countries: Anguilla, Antigua and Barbuda, Australia, Bahamas, Barbados, Belize, Bermuda, British, Indian Ocean Territory, Canada, Cayman Islands, Dominica, Falkland Islands, Gibraltar, Grenada, Guinea, Ireland, Jamaica, Malta, Montserrat, New Zealand, Pitcairn, South Georgia and the South Sandwich Islands, St Helena, St Kitts and Nevis, St Lucia, Trinidad and Tobago, Turks and Caicos Islands, United Kingdom, United States, Virgin Islands (British)
- **English-Medium Instruction (EMI) Waiver** – Completion of 3+ years at an accredited secondary school where English is the principal language of instruction. Submit an official transcript and a signed letter on school letterhead confirming “Medium of Instruction: English.”
- **U.S. College English Coursework** – Completion of transfer-level Academic Reading and Writing (e.g. - ENGL C1000 or equivalent) at a U.S. accredited college/university with a grade of C or better. Submit official transcript and course description.
- **Partner Pathway**– Must submit official transcripts reflecting successful completion of ELS Level 109.

Admission Steps & Required Documents (cont.)

Official Transcripts Evaluation

- Applicants must provide proof they have at least the equivalent of a U.S. high school graduation. Foreign transcripts must be evaluated by an international evaluation service for general education credit. We recommend using [International Education Evaluations](#).

Immigration Information

F-1 STATUS

Once you are admitted to NVC, you will be issued a certificate of eligibility called an I-20 for F-1 students. This certificate of eligibility (also known as a visa document) must be used to apply for a student visa at a U.S. Consulate or Embassy. After your student visa is issued, you can make plans to come to the U.S. (Note for Canadian citizens: a student visa is not required but you must obtain F-1 status when you enter the U.S.)

SEVIS

The Student and Exchange Visitor Information System (SEVIS) is a database system used by the U.S. Department of Homeland Security (USCIS) and SEVIS-approved educational institutions to monitor students in F-1 status. Your SEVIS number is printed on your I-20.

What you will need to apply for an F-1 Student Visa:

1. Acceptance Letter from Napa Valley College

- You must be accepted into a full-time academic program at a U.S. school certified by the Student and Exchange Visitor Program (SEVP).

2. Form I-20 (Certificate of Eligibility)

- Issued by your U.S. school's Designated School Official (DSO) after admission and financial verification.

3. Valid Passport

- Your passport must be valid for at least six months beyond your intended stay in the U.S.

4. Completed DS-160 Form

- Complete the Online Nonimmigrant Visa Application (Form DS-160) and print the confirmation page for your interview.

5. Visa Application Fee Receipt

- Pay the nonrefundable visa application fee and retain the receipt.

6. I-901 SEVIS Fee Receipt

- After receiving your Form I-20, pay the SEVIS fee at fmjfee.com and keep the receipt.

7. U.S. Visa Photo

- Provide a recent passport-style photo that meets U.S. visa photo requirements (2x2 inches, white background).

8. Proof of Financial Support

- Demonstrate sufficient funds to cover tuition and living expenses for your entire course of study. Acceptable documents include:
 - Bank statements
 - Affidavits of support
 - Scholarship letters
 - Financial guarantee letters

9. Evidence of Ties to Your Home Country

- Provide documentation showing your intent to return home after your studies, such as:
 - Job offers
 - Family obligations
 - Property ownership

10. English Proficiency Test Scores (if applicable)

- Some visa officers may request proof of English proficiency, depending on your background and program requirements.

Tips for Your Visa Interview

1. Be Clear About Your Academic Plans

- Know the program, degree, and school you've been accepted to.
- Be prepared to explain why you chose that school and how it fits your future goals.

2. Show Strong Ties to Your Home Country

- The F-1 visa is non-immigrant. You must provide proof to the officer that you plan to return home after your studies.
- Mention family, job prospects, property, or future career plans in your home country.

3. Know Your Financials

- Be ready to explain who is funding your education (e.g., parents, sponsors, savings).
- Understand and articulate the amounts listed on your bank statements or financial documents.

4. Practice Concise Answers

- Visa interviews are often under 5 minutes.
- Answer clearly, honestly, and confidently—avoid overly long or vague responses.

5. Bring Organized Documents

While you may not be asked for everything, bring:

- I-20 Form
- SEVIS Fee Receipt (I-901)
- DS-160 Confirmation Page
- Valid Passport
- Visa Photo
- Admission Letter
- Bank Statements/Financial Docs
- Academic Transcripts/Test Scores (if applicable)

6. Dress Neatly and Arrive Early

- Business casual attire is appropriate.
- Arrive early to allow time for security checks and screening.

7. Be Honest

- Never falsify documents or lie. If you don't know something, it's better to say so honestly than guess.

8. Stay Calm and Polite

- The officer may seem serious—that's normal. Remain respectful and don't argue or show frustration.

Traveling to Napa

Fly into **San Francisco (SFO)** or **Sacramento (SMF)**—each about 1.5 to 2 hours from Napa. Use shuttle services or rideshare apps (like Uber or Lyft) to reach campus. NVC does not currently offer airport pickup.

Students with confirmed housing at River Trail Village should coordinate their move-in timing directly with the housing team. To do so, please contact: rivertrailvillage@assetliving.com

We strongly recommend arriving during daylight hours and arranging transportation in advance to ensure a smooth and stress-free arrival experience.

Tuition and Fees

International students are required to pay the current per-unit tuition rate for international students, along with any applicable college fees. For the most up-to-date information, please visit our [website](#).

There is no financial aid available for international students.

Payment is due immediately upon registration.

Napa Valley College enforces a Pay-to-Stay policy, which provides students a 14-day grace period from the date of registration to pay in full. **If payment is not received within this period, students may be dropped from their classes for nonpayment.**

Tuition and enrollment fees will be collected in full at the time of registration. Based on the 2025- 2026 academic year, the estimated cost of attendance is as follows:

\$12,984	Tuition & Fees based on 24 units minimum required for F1 visa student.
\$11,835	Food and housing (based on home stay)
\$1,089	Books and other educational expenses
\$1,818	Transportation
\$4,140	Miscellaneous and personal
\$1,000	Mandatory medical insurance
\$32,866	Total

Tuition is subject to change.

Costs above are based on the 2026-2027 academic year and will be adjusted annually. Students who choose on-campus housing will have a variable cost for housing depending on which type of accommodation they select. In support of the F-1 visa application, a current bank statement must show a minimum balance to cover at least the amount needed for the total cost of one academic year's expenses.

Tuition Refunds – Non-resident and International Students Only

Out-of-state and international student tuition will be refunded according to the application date based on the following schedule:

- During the first two weeks of instruction. 100%
- Third week of instruction. 50%
- Fourth week of instruction.25%
- After Fourth week of instruction.0%

Appealing Your Fees

To appeal a decision concerning your fees, file a "Petition for Late Add, Drop, or Refund" by the end of the semester the fees are incurred. For more information, call the Admissions and Records Office at (707) 256-7201.

Maintaining Status

As an F-1 international student, you must follow specific immigration rules to remain in lawful status while studying in the U.S. Failing to follow these rules could affect your ability to stay in the country or continue your studies. The guidelines below highlight key responsibilities and provide trusted resources to help you stay on track. Always reach out to your Designated School Official (DSO) if you have questions or plan to make changes to your schedule, or travel plans.

Maintain Full-Time Enrollment

- Enroll in a full course load each academic term. This means registering for a minimum of 12 credit hours per semester, with at least 9 of those units delivered in-person or in a hybrid format to maintain immigration status.
- If you need to drop below full-time, obtain prior approval from your Designated School Official (DSO) and ensure a Reduced Course Load (RCL) is authorized.

Keep Your Immigration Documents Valid

- Ensure your passport is valid at all times.
- Keep your Form I-20 current and accurate. If there are any changes in your program, major, or personal information, notify your DSO to update your I-20 accordingly.
- If you need more time to complete your program, apply for a program extension before your I-20 expires.

Work Only with Proper Authorization

- Do not engage in any employment without prior authorization.
- On-campus employment is generally permitted up to 20 hours per week during the academic term.
- Off-campus employment, including Curricular Practical Training (CPT) and Optional Practical Training (OPT), requires prior approval from your DSO and USCIS.

Report Changes Promptly

- Inform your DSO within 10 days of any changes to your U.S. address, phone number, or legal name.
- Report any changes in your academic program, such as a change of major, early graduation, or transfer to another institution.

Travel Responsibly

- Before traveling outside the U.S., ensure your I-20 has a valid travel signature (signed within the last 12 months; within 6 months if on OPT).
- Carry all necessary documents when re-entering the U.S., including a valid passport, visa, and I-20.
- Avoid re-entering the U.S. with an expired visa unless eligible for automatic visa revalidation.

Depart the U.S. on Time

- After completing your program, you have a 60-day grace period to depart the U.S., transfer to another SEVP-certified school, or apply for a change of status.
- If you complete OPT, you also have a 60-day grace period after your employment authorization ends.

Maintain Communication with Your DSO

- Regularly check in with your DSO to ensure your SEVIS record is up to date.
- Consult your DSO before making decisions that could affect your immigration status, such as withdrawing from classes or changing your course of study.
