### UK ETA VISUAL GUIDE

Please feel free to refer to this visual guide when completing your UK ETA online. This visual guide will show the process when using the website. If you are using the app instead, please note things may look a bit different. All the requested information should be the same, however.

Before starting your application, please have the following information ready:

- 1. Passport
- 2. Headshot photo/selfie\*
- 3. Payment method, such as a credit card, debit card, Apple Pay or Google Pay (the ETA cost is £10 per person)

\* Please note the photo requirements are that it must be larger than 500KB and must be at least 600px x 750px. Photos must also be a .JPG or .JPG file type.

You will not need any information about flights, hotels, tour itinerary, etc. The only information the ETA will ask for is your information, such as email, phone number, home address, and some personal questions.

**FOR THOSE USING THE APP**: You will be asked to scan the chip in your passport. Please note this chip can be in a different location depending on your passport issuing country, how long ago it was issued, etc.

- 2. Scan your face with your device, if it has a camera. Children aged 9 and under will not be asked to scan their face.
- 3. Take or upload a photo of yourself.
- 4. Answer some questions about yourself.
- 5. Pay for your application.

#### Before you apply

You will need to complete your application in one go - you cannot save your progress.

If you do not do anything for 20 minutes, the service will time out. Your answers will be deleted and you will need to start again.

By applying, you agree to the <u>Electronic Travel Authorisation (ETA) privacy</u> notice.

• You will need to provide an email address to use for communication for the ETA. The application will send a code to that email, which you will then need to input into the box labeled "Security code."





• Next you will need to take or upload a photo of your passport, as the ETA itself will be linked to this passport. Please follow the outlined photo requirements.

The photo or scan must show:

- All 4 corners of the personal details page
- Your personal details
- The photo of you
- The machine-readable zone

## Upload or take a photo of your passport

You need to provide a photo of the passport you will use to travel to the UK. Your ETA will be linked to this passport.

#### Photo requirements

You must provide a photo of your physical passport. Your application may be rejected if you upload or take a photo of a digital passport.

The photo or scan must show:

- all 4 corners of the personal details page
- your personal details
- the photo of you
- the machine-readable zone (MRZ)

The MRZ is 2 or 3 lines of letters, symbols and numbers, at the bottom of the personal details page on your passport.



The photo or scan must be:

- clear and in focus
- without glare or reflections

### **Check your information**

Make sure it matches the machine readable zone (MRZ) on the passport you will use to travel to the UK.

The MRZ is 2 lines of letters, symbols and numbers, at the bottom of the personal details page on your passport.



Do not worry if your name is shortened or does not include:

- hyphens
- apostrophes
- accents
- other special characters

Check your name matches the MRZ on your passport. It only has letters A to Z and spaces.

#### If you are applying for someone else

If you are applying for someone else, you need to scan their face - not yours.

If they are not with you, you can <u>skip this step</u>. This will not affect their ETA application.

- Your head, shoulders, and upper body must be visible
- Even lighting
- No shadows or glare on your face or behind you

• Next the application will ask if you've been involved in or suspected of any of the below activites listed. If you select **Yes**, it will ask you to select which of them apply to you. If you select **No**, it brings you to the next question.

 After this there will be a review screen. You should review all of your information for accuracy before proceeding. You cannot change any details in your application after you have submitted it. Please note you will not be able to get a refund after you apply.

## Declaration

By sending this application, you confirm that, to the best of your knowledge, the information you have given is correct.

If you have given any false information:

If you are applying on behalf of someone else you must have confirmed with them that the application is complete and correct.

• Once your payment has been applied and the application is complete, you will receive a confirmation email to the email address you previously used. When a decision has been made, you will receive another email advising the confirmation or denial of your ETA. On average, you should allow up to 3 working days (Monday through Friday) to receive a decision, and it could also arrive sooner or later than that.

• Below is an example of what the approval email will look like.

## What you can do with an ETA

Your ETA allows you to travel to the UK for 6 months for:

- tourism
- · visiting family or friends
- business
- short-term study (courses up to 6 months)
- paid permitted engagement (you must do the engagement in the first 30 days of your visit)

You can also use an ETA to:

- · transit through the UK
- · come to the UK for up to 3 months as a creative worker
