Dr. Bishop has served on two peer review teams.

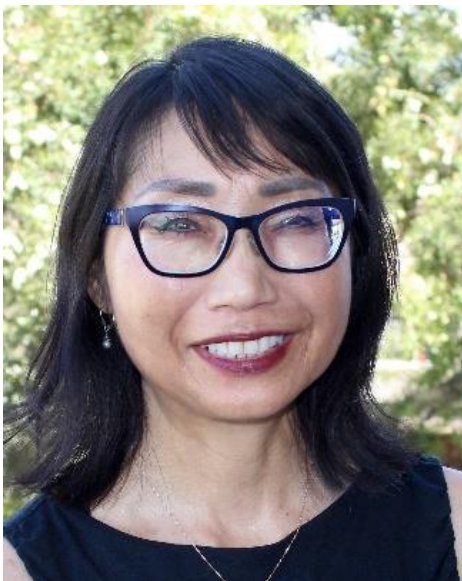
