Rationale

Revisions meet the BRN requirements. Placement sites that offer face-to-face clinical hours are difficult to find in the pediatric setting for all forty students as many sites only take one-two students and schedules are varied. The overall units of this course were not decreased, but the clinical lab hours are. A minimum of 30 face-to-face lab hours are required by the BRN for this course, but the remaining lab hours may be obtained through simulation and skills practice. Discussed with the BRN representative that the reduction of overall program and course hours and units is necessary in anticipation of reduction to the 16-week long semester, other factors were the title IV possible government reductions in overall program hours, as well as the reduced numbers of students allowed in clinical site placements due to higher rate of new grad trainings and also full time faculty retirements. A lot of feedback from instructors and students about overall nursing course load which currently exceeds 36 unit minimum required by BRN. The other proposal is that this course be a permanent hybrid course (it is currently hybrid for emergencies) to facilitate lecture due to the varied clinical days of the week due to multiple clinical sites. This will facilitate meeting the course objectives for both students and the instructors.

Catalog Course Description

Using concepts and skills previously introduced, this course focuses on the use of nursing process in the promotion of health and wellness in the pediatric client/ family as well as the pediatric patient with and without alterations in health. Emphasis is placed on health alterations specific to the pediatric client being cared for in the out-patient setting, acute alterations in the out-patient setting, and for chronic alterations. The hospitalized pediatric patient with acute health alterations in pediatrics will be incorporated in the acute medical surgical courses.

- Pediatric Content:
 - a. Developmental theories (infant through adolescence) will be discussed across the continuum of care including community settings.
 - Pediatric assessment and Physical Exam (normal vital signs, normal growth and development inclusive of growth charts, Denver II tools)
 - c. Promotion of wellness (Nutrition: dietary patterns, formula feedings, breast feeding, special diets. Safety needs. Influencing factors: type of family, cultural heritage, socioeconomic status, environment. Barriers to care.)
 - d. Caring for children and their families.
 - e. Care for children with both chronic and acute illness.
 - f. Disease Prevention: mortality, morbidity, immunizations.
 - g. Learning style, teaching strategies for infants, toddlers, pre-school child, school age child, and adolescents.
 - h. Safety as a major risk for children will be presented including developmental characteristics that lead to accidents, characteristics of accident-prone children; prevention; available school and community resources agencies
 - i. Abuse
 - j. Legal & Ethical Issues inclusive of informed consent
 - k. The ill/injured child: the child's experience, the family's experience
 - I. Stressors
 - m. Crisis: common reactions, nursing care, case management, community resources
 - n. Principles and nursing implications of medication administration in pediatric clientele: Calculating dosages, Techniques of administration, IV administration
 - o. Pre- and post-operative care
 - p. Management of pain
 - q. Therapeutic play: types; age-specific activities
 - r. Treatments/Procedures in pediatrics: oxygen administration, apnea monitors, telemetry, resuscitation, heel sticks, restraints, transportation
 - s. Care in a variety of settings: home, outpatient clinic, emergency room, long term care, physician office
