- There is a narrative that the senate doesn't know how to do shared governance. There were processes working, but processes were also being sabotaged. We can revise a process but through the mutual agreement process.
- CIA visit on Sept. 1. AS President shared a list of items to cover: role of Trustee, role of the senate, definition of collegial consultation, role of the templates in policy review process.
- o AS President vocalized shared governance had been suspended and we haven't done mutual agreement in a year.
- Will discuss who from other constituent groups will be present.
- Faculty strongly advocated for members of other constituent groups to participate on Sept. 1.
- The Implementation of Guided Pathways, ACIP, Equity, and IEPI
- o IEPI will allow for training around shared governance
- CCRC Summer Institute attendees examined data, discussed how to better coordinate, and brainstormed activities for Fall 2022.
- o Group asked Dr. Powell for institutional support
- IEPI: Moving from Professional Development to Professional Learning
- We applied and last year received a \$200K grant for professional learning
- Center for Equity and Excellent in Teaching and Learning (CEETL) will begin by focusing on 4 areas: AS Professional Learning Committee, AS Instructional Design Institute, Institute for Governance and Academic Freedom, CEETL Research Team.
- AS Professional Learning Committee will hopefully develop the infrastructure of CEETL, coordinate areas, develop themes and topics for flex days, manage professional development grants.
- AS Instructional Design Institute: create curricula for 3week and 4-week learning strands and multi-level skill strands; expand CRP and DE pedagogy, link to the NVC Cultural Center; explore interest with community partners. Explore how we can get load for teaching and taking noncredit PL strands.
