NextUp is a program that assists students who are <u>current or former</u> foster youth attending any California Community College.

### **BEFORE SUBMITTING A NEXTUP APPLICATION, YOU MUST:**

Be enrolled for the current semester at Napa Valley College.

Complete the NVC *New Student Orientation* <u>www.napavalley.edu/counseling</u> (if applicable).

Apply for financial aid (2025 - 2026 FAFSA or CA Dream Act application) and work toward submitting all additional documents required by the Napa Valley College Financial Aid Office.

Submit verification of Foster Youth Status (official letter from the county, Chafee Grant eligibility, proof of enrollment in the NextUp Program at another community college).

#### **OTHER INFORMATION:**

- Admission into the NextUp program is NOT automatic. You must be declared eligible by the NVC NextUp program to be admitted into the program.
- The *eligibility screening process takes <u>at least four weeks</u> to complete.* Please allow more time during the beginning of the semester due to the high volume of submitted applications.
- The NextUp/EOPS Office will notify you via your NVC student email regarding your eligibility for the program(s).
- Once determined eligible, you <u>must</u> attend a NextUp *New Student Orientation*.
