EOPS, CARE & NextUp Services:

Counseling: Our EOPS, CARE & NextUp counselors offer academic and personal counseling, career guidance, transfer assistance, and educational planning.


Priority Registration: students are eligible to register for classes before the general student population.

Book Voucher Program: Eligible students are issued a voucher to help purchase required textbooks each semester.

Transfer Assistance: Our counselors provide help with the transfer application process, scholarship search, letters of recommendation, and campus visits.

Tutoring Services: provides academic tutoring in several subjects.

Coordination with other academic support services on campus: We make referrals to tutoring services, student success workshops and cultural events. We sponsor membership in the Phi Theta Kappa and the Alpha Beta Gamma Honor Societies and help with the purchase of graduation caps and gowns for eligible EOPS, CARE and NextUp students.

¹ Submit a FAFSA or CA Dream Act Application for the current academic year and list Napa Valley College as your school of attendance.

² Submit current academic transcripts from all prior colleges (other than NVC).


Complete an EOPS, CARE & NextUp application and submit it to our office (check our webpage for specific application dates).

What is EOPS?

EOPS stands for Extended Opportunity Programs and Services, and it is a state-funded program that offers "over and above and in additions to" services already provided at Napa Valley College. These services are specifically designed to provide equitable access to education for students who are economically and educationally underserved.

Who is eligible for EOPS?

Students may be eligible for the EOPS program if they meet **all** of the following requirements:

- Eligible for a Board Of Governors Fee Waiver under method A or B, with a "0 EFC" from federal financial aid
- Apply for FAFSA or CA Dream Act application and be in good academic AND financial aid standing
- Register as a full-time student at NVC (12 or more units)
- California resident or AB540 student (confirmed by the NVC Admissions Office)
- Completed less than 70 degree applicable college units from all colleges attended
- Educational disadvantage



What is NextUp?

NextUp is a supplemental component of the EOPS program that specifically assists students who are current and/or former foster youth attending Napa Valley College. The NextUp program provides additional services to those already provided by the EOPS program and can include help with transportation and emergency housing assistance.

Who is eligible for NextUp?

- Be a current or former foster youth.
- Dependency or ward of the court on or after your 13th birthday (student will be asked to provide verification).
- Be under 26 years of age before July 1st of the academic year in which the student attempts to enroll in the program.
- Working towards enrollment in 9 units.

What is CARE?

Currently receives CalWORKs benefits and/or have an approved County Welfare to Work (WTW) plan.
