## VA Isakson and Roe Section 1018 (Shopping Sheet/College Financing Plan)

Section 1018 of Public Law 116-315, <u>Johnny Isakson and David P. Roe, M.D. Veterans Health Care and Benefits Improvement Act of 2020</u>, requires educational institutions to make certain disclosures to students using federal military and/or VA education benefits. ### **Additional Information**

<u>In-state Tuition</u> – Students actively using Montgomery GI Bill®–Active Duty program (Chapter 30), the Veterans Readiness and Employment program (formerly called Vocational Rehabilitation and Employment) (Chapter 31), the Post-9/11 GI Bill® program (Chapter 33) and Dependents Educational Assistance

(Chapter 35) are exempt from paying nonresident tuition regardless of when the veteran separated from the military. Please begin by filling out the Statement of Legal Residence and attaching your proof of current California residence and Certificate of Eligibility https://www.napavalley.edu/admissions-and-aid/admissions-and-records/forms.html
