




## HOW TO DEAL WITH DIFFICULT OR DISRUPTIVE STUDENTS IN YOUR CLASSROOM/OFFICE

At Napa Valley College, we have established procedures that outline students' responsibilities and rights in an effort to create and ensure an atmosphere that is conducive to learning and teaching. The information below will assist faculty and staff in becoming knowledgeable of District rules and procedures related to student conduct. On the reverse side, we have listed some resources available to students that you can reference for referrals. Instructors have the prerogative to interpret this based on their own experience. You always have the right to contact campus police (707) 256-7777 or city police at 911.

Dealing with:	Established Procedure:
<p><b>A student's misconduct or disruption in your classroom:</b></p>	<p><b><i>Minor Incident/Disruption:</i></b></p> <ul style="list-style-type: none"> <li>• Talk to the student individually before or after class to discuss behavior, and your expectations for appropriate classroom conduct. Share a copy of the <b>Student Code of Conduct</b> (aka Standards of Student Conduct) with him/her and inform the student of the sanctions/consequences for repeated misconduct. Copies can be obtained from <a href="http://www.napavalley.edu/studentaffairs">www.napavalley.edu/studentaffairs</a>, by clicking on the College Policies and Procedures section.</li> <li>• <b>Document the occurrence in writing.</b> (This is very important, especially if the situation continues or escalates; the Senior Dean of Student Affairs cannot reprimand the student or institute any disciplinary actions without sufficient information.)</li> </ul> <p><b><i>Escalated or continued disruption:</i></b></p> <ul style="list-style-type: none"> <li>• If disruptive behavior is impacting your teaching or continuance of the class, ask the student to leave the class for that class meeting and to make an appointment with the Senior Dean of Student Affairs in order to obtain approval to return to the next class meeting. For more details on this process, please refer to the <a href="#">Standards of Student Conduct</a>, Section IV: Procedures.</li> <li>• After initial disruption has passed, fill out the <a href="#">Student Code of Conduct Violations Incident Report</a> to notify the Senior Dean of Student Affairs and determine the next appropriate step. You can also contact College Police, (707) 256-7770, if necessary.</li> </ul>
<p><b>A student who is aggressive or threatening:</b></p>	<ul style="list-style-type: none"> <li>• Contact the College Police immediately, (707) 256-7777.</li> <li>• Do not leave the class unattended. Instead ask a student to call College Police from a nearby office or use the NVC Safe App on their phone.</li> </ul> 
<p><b>A crime on campus or questions about your personal safety:</b></p>	<p>NVC Police will take reports of crimes and can advise you if you have concerns about your safety. Their office is located in 2250 Building, (707) 256-7777.</p>
<p><b>A student who is struggling academically in your classroom:</b></p>	<p>Talk to the student in private and recommend that they make an appointment to see a counselor in the <a href="#">Counseling Department</a>, (707) 256-7220, Rm 1339A. Counselors can help students deal with workload dilemmas, personal difficulties, and other issues that may interfere with academic success at NVC.</p>

Dealing with:	Established Procedure:
<b>A student who wants to file a complaint or grievance:</b>	<ul style="list-style-type: none"> <li>• While it is our hope that concerns, complaints and problems can be minimized through direct communication between those involved (informal processes), in some cases formal action is required. All students have the right to utilize the Student Complaint and Grievance Procedures set up to resolve problems.</li> <li>• Refer student to the Student Complaint and Grievance Policy and Procedures Booklet available online on the Student Affairs webpage (<a href="http://www.napavalley.edu/studentaffairs">www.napavalley.edu/studentaffairs</a>). Or, direct student to obtain a hardcopy at the Office of the Asst. Superintendent/Vice President of Student Affairs, Room 1330.</li> <li>• Refer student to the handout titled “Getting Help with Difficulties You Encounter at NVC”, also found online on the Student Affairs webpage, under the College Policies and Procedures section.</li> <li>• Make student aware of the college’s ombudsperson (student advocate), who can help explain District processes and refer them to appropriate parties to resolve their student concern.</li> </ul>
<b>A student who was caught cheating or you suspect is cheating:</b>	<ul style="list-style-type: none"> <li>• Talk to the student individually before or after class to discuss incident and your expectations for academic standards of honesty.</li> <li>• Refer to the Academic Honesty Policy found on the Student Affairs webpage, under the College Policies and Procedures section, and share a copy of this policy with the student. As the instructor of the class, you have the right to enforce one or more of the disciplinary actions or consequences of academic dishonesty listed therein.</li> <li>• If necessary, and/or second infraction, refer student to the Senior Dean, Student Affairs for disciplinary action, (707) 256-7364.</li> </ul>
<b>If you are unsure how to deal with an issue or student:</b>	Always seek assistance from your division chairperson first. But if still unsure on how to deal with a student situation, you may contact the CARE Team, (707) 256-7776 or contact the Office of Student Affairs, (707) 256-7363 or (707) 256-7362, <a href="mailto:NVCStudentAffairs@napavalley.edu">NVCStudentAffairs@napavalley.edu</a> .
